

CORRIGENDUM - I

**KAMARAJAR PORT LIMITED

1. The page no.12 of 66 in Clause no.9(i) in Part-3, Section-I. Scope of work and instructions to the tenderer of tender document is amended and to read as under.

9(i). *Eligibility Criteria: Minimum Eligibility Criteria:*

- (a) The bidder should currently be a Government Approved Valuer and should be in compliance with provision of Section 247 of the Companies Act –2013 and the Rules framed therein, i.e., Companies (Registered Valuers and Valuation) Rules, 2017 and also any other relevant Government mandated rules & regulations and any other registration requirements applicable to undertake the valuation of immovable properties.
- (b) The bidder should be empanelled with PSUs/ Government Departments/ Government Banks/State Governments/ Government Autonomous bodies.
- (c) The bidder should be mandatorily registered with Principal Commissioner Income Tax Department, under Section 34AB of Wealth Tax Act, 1957 Read with Rules.
- (d) The bidder should be registered with Insolvency & Bankruptcy Board of India. The bidder should be registered with IOV Registered Valuer Foundation, New Delhi with valid Member-ID or with other similar RVOs under IBBI”.

Clause -9 (iv):

Documentary proof such as copy of Notarized or self attested work order / agreement and completion certificate for the technical experience and audited balance sheets, Profit & Loss account statements for last three financial year ending March 2019 shall be uploaded under tender document - technical bid link through e-procurement mode. The successful

Tenderer should produce the original documents for verification before award of work. The bidder must possess the experience certificate of similar works executed only from State Government/ Central Government / Public Sector undertaking organization/ PSU banks/ /Railways /Autonomous bodies. The price bid of the tenderer will not be opened if the tenderer do not meet the eligibility criteria on technical aspects in cover I. All the documents as per Form-I,II,II(a),III,IV,V,VI,VII,VIII & IX and a undertaking in Rs.100/- stamp paper, Annexure- 1, annexure a, b, c shall be uploaded through e-procurement portal after scanning in pdf format in the Tender Document – Technical Bid.

Note: The exemption certificate from NSIC/MSME is applicable for exemption from payment of EMD only. Copy of NSIC/MSME should be uploaded along with the Technical bid failing which the tender will be disqualified/ Rejected.

2. The page no.14 of 66 in Clause no.11(i)(e) in Part-3, Section-I. Scope of work and instructions to the tenderer of tender document is amended and to read as under.

11.0 Conditions of Tender:

Clause -11(i): The bidder should upload bids through online website www.eprocure.gov.in and it should contain the Notarized or self attested of the following.

Clause -11(i): (e) Certificate for Registered as a valuer in IBBI and Income Tax Department.

Further, the bidder would be requested to submit a undertaking in Rs.100/- stamp paper as per the format (copy enclosed).

The date of submission of above mentioned tender has been extended upto 30.03.2020 @ 15:00 hours. The due date for opening of Technical bid is 31.03.2020 @ 15:30 hours.
