AMENDMENT TO THE REBATE IN VESSEL RELATED CHARGES I.E. PORT DUES AND PILOTAGE CHARGES FOR VESSELS CARRYING EXIM TRANSHIPMENT CONTAINERS AT KPL.

KPL is pleased to inform to the Trade that, an amendment has been made to the Trade Notice No. 12/2020 dated 27.11.2020 issued for Rebate in Vessel Related Charges i.e. Port Dues and Pilotage charges for vessels carrying EXIM Transhipment Containers at KPL.

The amended Rebate in Vessel Related Charges i.e. Port Dues and Pilotage charges on Scale of Rates (SoR) shall be offered to those foreign going vessels which handle EXIM Transhipment Containers at KPL, subject to the following conditions:-

1. For Mainline calls:

Qualifying Criteria (QC)	Rebate if QC is achieved (%)	Rebate if QC is not achieved (%)
(a) A minimum of 1,000 TEU's of EXIM Transhipment Containers are handled in a call and the EXIM Transhipment Containers TEU's handled is at least 50% of the total Containers TEU's handled at KPL in that call and	85	50
(b) The Mainline vessel making a call is having more than 40,000 GRT.		

2. For Feeder Vessel calls:

Qualifying Criteria (QC)	Rebate if QC is achieved (%)
A minimum of 500 TEU's of EXIM Transhipment Containers are handled in a call.	50

3. This Amended Trade Notice supersedes the Trade Notice No. 12/2020 dated 27.11.2020.

- 5. The Rebates provided under this Notice cannot be clubbed with any other Rebates/Concessions.
- **6.** This Rebate shall be offered on a promotional basis for a period of one year from 01.06.2022 and shall be reviewed thereafter.
