**ONLINE RFID PORT ENTRY / EXIT PASSES AT KAMARAJAR PORT LIMITED**

The Port users / Trade are aware that, Kamarajar Port Ltd has implemented online RFID Port Entry/Exit passes with effect from 01.04.2017. It is mandated that, men and vehicle entry to Port shall be allowed with valid RFID Card and Tag respectively.

In the recent period, the Container trailers are entering the Port without RFID passes which in turn creates huge traffic congestion and also delay in obtaining RFID passes at Truck parking yard. In order to reduce the congestion, all the Transporters are requested to complete the registration process and obtain RFID passes through online RFID Pass Issuance System prior to entering the Port.

**Applying for RFID Online Pass:**

For RFID online registration as Transporter, requisition email / letter shall be sent to the [traffic@kplmail.in](mailto:traffic@kplmail.in) / [traffic.epl@gmail.com](mailto:traffic.epl@gmail.com) for allocating RFID Pass Issuance System **login id & password**. The procedure (SOP) to be followed by the Port users for registration of vehicles and drivers is available at below link.

**RFID Card & Tag:**

1. The cost of RFID Card is Rs. 140/- and RFID Tag is Rs. 123/- which shall be purchased through online RFID Pass Issuance System and shall be collected from the Port Pass section.


